



## INTERNATIONAL LEAP/CSCIP MEMBERSHIP APPLICATION

*For new LEAP/CSCIP members located outside of the United States only*

International LEAP/CSCIP membership is combined for individuals located outside of the United States. This combined application form must be submitted to the Smart Card Alliance for acceptance into the LEAP/CSCIP program and to enroll in the CSCIP certification training program. LEAP/CSCIP is open to all individual professionals working in the smart card industry in the United States and worldwide, regardless of whether their organization is a current member of the Smart Card Alliance. First year LEAP membership fees are INCLUDED in the International CSCIP smart card training and certification exam fee. Future LEAP membership is billed on a calendar year basis with proration during the second year.

International Certified Smart Card Industry Professional (CSCIP) designation requires the completion of the CSCIP smart card training course and CSCIP exam. A separate CSCIP Training, Documentation and Exam Order Form must be submitted for acceptance into the CSCIP certification program.
